3. COMPOSITION/INFORMATION ON INGREDIENTS

A small proportion of the fine dust associated with this product will contain 'Respirable Crystalline Quartz' (RCQ). While the product is wet and being applied as per the directions on the package the amount of airborne RCQ will be minimal but it is still recommended that proper PPE is worn. Once dry any residues, grinding or strong abrasive forces may reintroduce RCQ into the air so caution should be taken.

Additional Information - Aggravated Medical Conditions

Inhalation Over exposure resulting from prolonged and repeated inhalation of dust containing

crystalline silica can cause bronchitis, silicosis (scarring of the lung.) It may also increase the risk of scleroderma (a disease affecting the connective tissue of the skin, joints, blood vessels and internal organs) and lung cancer. Epidemiological studies have shown that smoking increases the risk of bronchitis, silicosis (scaring of the lung) and lung cancer in

persons exposed to crystalline silica.

Skin Prolonged and repeated skin contact with cement in wet concrete, mortars and slurries

may result in irritant dermatitis or alkaline burns.

permanent damage.

11. TOXICOLOGICAL INFORMATION

Acute Toxicity No known toxicity data available for this product.

Eye Irritant upon contact with dust. Over exposure may result in pain, redness, corneal burns

and ulceration with possible permanent damage.

Inhalation Irritating to the respiratory system, causing coughing and sneezing. Over exposure may

result in severe mucous membrane irritation and bronchitis. Hexavalent chromium is reported to cause respiratory sensitisation, however due to the trace amount present a hazard is not anticipated under normal conditions of use. Crystalline silica can cause silicosis (lung disease) with chronic over exposure, however due to low levels present and

product application, adverse health effects are not anticipated.

Skin Irritating to the skin. Prolonged and repeated contact with powder or wetted form may

result in skin rash, dermatitis and sensitisation.

Ingestion Slightly corrosive. Ingestion may result in burns to the mouth and throat, with vomiting

and abdominal pain. Due to product form, ingestion is not considered a likely exposure

route.

Mutagenicity Insufficient data available for this product to classify as a mutagen.

Carcinogenicity Brickies Grey Mortar is not classified as a carcinogen by NOHSC. Crystalline silica and

hexavalent chromium compounds are classified as carcinogenic to humans (IARC Group 1), however due to low levels present and product application, the criteria for classification

is not met.

Symptoms of exposure include itchy, tender, swollen, hot, cracked or blistering skin with the potential for sensitisation. The dermatitis is due to the presence of soluble hexavalent chromium.
